## PLAYERS

This is an **invitational** tournament for a maximum of 60 amateur players, male and female under 25 years old category, of which 30 places for UGPM, leaving 30 places available to enter in order of handicap (15 for each category).

## REGISTRATION

It must be submitted before 23:59 pm on Monday the 28th of November. The order of entry will be by handicap.

**The registration fee will be 150 euro.** In case of **no-show** the registration fee will not be refunded.

## PRACTICE ROUND

The official day for practice round will be on Thursday 1st of December after 12 hours with a special price of 30 euros. Any other date for practice round and the tee times will be booked directly with the Club.

## **TROLLEYS**

The Club has a limited number of Trolleys. They must be booked directly there.

## **CADDIES & LASER**

Allowed.

## **BUGGIES**

Not allowed.

## **TEES**

White and blue tees.

## **TEE TIMES**

Friday 2nd: first round.

Saturday 3rd: second round.

Sunday 4th: final round.

The tee times will be published 48 hours before on [www.ugpmalaga.com](http://www.ugpmalaga.com) .

## **WAGR**

This tournament will be scored for WAGR as long as it has a minimum of 8 players in the male category and 8 in the female category.

## RULES

### PLAYERS

Invitational tournament reserved for amateur players with a valid federation license and under 25 years of age.

### CATEGORY

Under 25 years old male and female category.

### GAME MODE

The tournament will be played under the game modality (Stroke play) by individual strokes to 54 holes (18 holes per day).

### READY GOLF

In stroke play, "Ready Golf" should be played, but in a safe and responsible way. Play when you are ready - you don't have to wait until the farthest away player has played. You will be encouraged by a referee to play "Ready Golf" if your group falls behind.

For example, play Ready Golf:

- When the player farther away has a difficult shot and is assessing options
- When a longer hitter has to wait for a green to clear
- On the tee if the player with the honor is delayed
- By playing your shot before helping to look for a lost ball
- Where possible, advise other player that you are going to play first

### RULES OF THE GAME

The tournament will be played in accordance with the Rules of Golf, the competition conditions and permanent Local Rules of the RFGA.

### REGISTRATION

Registrations must be made at least five days before the start of the test. **The order of entry will be by handicap.**

## **MAXIMUM NUMBER OF PLAYERS**

60 will be the maximum number of players.

## **TEE TIMES**

The start time will be carried out in order of handicap, starting first with the lowest handicap players.

On the second and third day, the starting order will be established by classification.

The Committee may vary the order of starts for any other reason if it deems it appropriate.

## **TEES**

White and blue bars.

## **REPLAY**

In case of a tie for first place, it will be resolved by playing hole by hole (from 18th) until one of the players achieves a lower result than the other.

## **TROPHY**

The first and second classified in each category will receive a trophy with the name of the event and Club in which it has been played.

## **SUSPENSION**

If any of the rounds of this tournament cannot be played, the committee will decide how to solve the development of the tournament.

## **TOURNAMENT COMMITTEE**

The committee will be formed by a representative of UGPM, a representative of the Club and the tournament director.

## **ANTI-DOPING REGULATIONS**

It is recalled that, in accordance with the regulations contained in Organic Law 3/2013, of 20th June, on the protection of the athlete's health and the fight against doping in sports activity and with current regulations, the Presidency of the Council Superior of Sports, by which the list of substances and methods prohibited in sport is approved, all athletes licensed to participate in official competitions at the state level will have the obligation to submit, in competition and outside of it, to the controls that determined by the Spanish Agency for the Protection of Health in Sports, when so provided.

## DATA PROTECTION

In order to comply the established in art. 5 of Organic Law 15/1999, of 13th December, on the Protection of Personal Data, and rules for its development, it is reported that for the proper development of the sports competition is essential to collect personal data from participants and these will be incorporated and processed in a computer file for the registration of players who take part in the Championships, whose purpose is to manage the aforementioned sports competition.
